• Call to Order

The meeting of the OC Animal Care Community Outreach Committee was called to order at 11:30 a.m. in the Learning and Training Room located at 1630 Victory Road, Tustin, CA 92782.

• Roll Call of Members

Public Comments

At this time, members of the public may address the Committee regarding any topic within the subject matter jurisdiction of the Committee provided that no action will be taken on any items not on the agenda, unless authorized by law. Comments shall be limited to three (3) minutes per person unless different time limits are set by the Chairperson subject to the approval of the Committee. The Clerk will run the timer and announce when time is expired.

Speaker #1 commented that they are experienced with data analysis and prepared reports based on data obtained from public record requests. OCAC is handling fewer animals, however its performance is worse. Adoptions should be streamlined by allowing the public to view dog kennels, focusing on behavioral issues, and improving socialization via playgroups. Poor performance costs more. Programs should be scaled. Pooches on the Patio and staff Pack Walks do not cover enough dogs or socialize dogs properly. Reports based on data from 2022. Predicts additional intakes in 2023.

Speaker #2 commented that they appreciate OCAC's assistance and response to an apartment-fire victim and approximately 10 cats. The owner attempted to contact different agencies for over 5 weeks before connecting with OCAC. Comments are dominantly about dogs. Believes cats are being neglected and urges spay and neuter programs to assist community members and cat populations.

Committee Member Dr. Malo moved to approve the minutes of January 25, 2023, seconded by Committee Member Kane.

Regular Business

1. Update from Ad Hoc Committee

Committee Member Dr. Malo stated he and Committee Member Amundson visited the shelter and spoke with the veterinarians of the facility. He was initially concerned about timed visits and believed people did not have opportunities to visit animals. After visiting, he found that people were happy with reasonable wait times. He felt that the shelter was doing a good job after seeing the statistics he was shown. He liked the dog and cat save rates, number of appointments, kennel enrichment, and that walk-ins are being seen.

Committee Member Dr. Malo commented that he received information from the first speaker and that he is concerned that there are different conclusions being drawn from the same data. He has not had the chance to digest the speaker's statistics. He would like to have a future, reasonable conversation and discuss further or involve a third party. Best practices of the industry are a good standard to be held to.

Director Andi Bernard stated that the next steps for the Ad Hoc Committee would be to meet again. Committee Member Dr. Malo would like to review the statistics. Director Bernard stated OCAC's statistics are consistent with animal welfare industry standards and the new statistics have been accepted into the record.

Committee Member Kim Kane asked if kennel walkthroughs are under consideration from the Ad Hoc Committee. Director Bernard stated that the committee will meet one more time, put their recommendations together, and reconvene at the Community Outreach Committee meeting.

Committee Member Feinberg asked if available dogs are removed from the site, or removed from an availability list, before adoption events. Community Outreach Manager Pantoja replied that subtype "mobile adopt" is still on the website under "lost and found." Adopted dogs from the off-site adoption event get

posted on the "happily ever after" page and unadopted dogs remain on the adoptable web page. This way dogs are put on hold, but also get to go to the special off-site event. Dogs with appointments do not get taken to the off-site events.

Committee Member Kane asked if there is an update for the Trap, Neuter, and Return program. Committee Member Dr. Malo replied that County legal stated we are not allowed to do TNR. Committee Member Feinberg asked if County Council can address this. Attorney Steinmann replied stating that his office has provided advice regarding this subject and the hurdle with Penal Code 597 (s), which prohibits the abandonment of any animal except for Californian native wildlife. This has been litigated by several jurisdictions and their office is ready to provide updated advice.

Committee Member Feinberg stated that Supervisor Katrina Foley's office provided the same answer and questioned why TNR was performed in the past and not now. Attorney Steinmann responded that he is unable to speak on that matter due to it being before his time with the agency. He speculated that it could be related to programs being challenged in a different way.

Committee Member Feinberg asked if TNR is being followed up upon or if it's a done deal. Committee Member Dr. Malo stated that legal is tracking. Director Bernard stated that OCAC is continuing to monitor the case in San Diego and San Diego Humane will recalibrate and monitor depending on the decision.

2. Community Outreach Team Goals for 2023 – Sandy Pantoja, Community Outreach Manager

Outlined goals for foster, volunteers, adoption partners, and public education programs. For public education programs, the aim is to increase public engagement with OCAC's social media platforms, engage in new partnerships and sponsorships, and update OCAC's website.

The foster program aims to increase education and resources via social media platforms, develop methods of communication with volunteers, increase foster program participation, and develop standardized training.

The volunteer program aims to create a structured schedule, identify internship opportunities, and develop methods of increased volunteer communication.

The adoption partner program aims to host quarterly meetings, enhance the Rescue Track webpage, and automate processes and notices for Rescue Track.

Public Comments for Community Outreach Team Goals for 2023

Speaker #1 commented that they are a plaintiff suing San Diego Humane Society for the return to field (RTF) of healthy, adoptable, non-feral cats. Stated there is no abandonment in Trap, Neuter, Release (TNR) programs and that TNR is for feral cats. Stated that OCAC needs to reinstate a TNR program.

Speaker #2 asked if there is a process for submitting data to the Ad Hoc Committee. Stated that for the California Penal Code to be in play, an OCAC representative would have to contact the District Attorney and attempt to prosecute. Is concerned that social media comments are turned off and that OCAC is underutilizing

public collaboration. Stated the public is frustrated but wants to see OCAC succeed. Concerned that committee members do not have the right attitude towards the public.

It was moved by Committee Member Dr. Malo, seconded by Committee Member Feinberg.

3. Public Education Program Report – Jackie Tran, Public Information Officer & Sandy Pantoja, Community Outreach Manager

This report summarized the second quarter activities of OC Animal Care's Public Education Program. Topics included the Let's Paws informational campaign, monthly adoption promotions, and programming such as Katy Cares, Pooches on the Patio, and Pet Food Pantry.

Public Comments for Public Education Program Report

None.

4. Foster Program Report – Sandy Pantoja, Community Outreach Manager

This report summarized the first quarter activities for OC Animal Care's Foster Program. 193 animals (146 kittens, over 40 puppies and 6 dogs) are participating in foster care. Quarterly Foster Coffee meet and greets to discuss foster programming. Held the first foster kitten shower of the year with bottle-feeding demonstrations and Q&A session with an RVT.

Public Comments for Foster Program Report

None.

It was moved by Committee Member Dr. Malo, seconded by Committee Member Kane. Ayes: 4 Nays: 0 Motion passed

5. Volunteer Program Report – Sandy Pantoja, Community Outreach Manager

This report summarized the first quarter activities of OC Animal Care's Volunteer Program including contributions to handling, socialization, Pet Food Pantry, Pooches on the Patio, and off-site adoptions events. The program held its monthly Volunteer Coffee and onboarded 38 new volunteers.

- Committee Member Thomas asked if there is a monthly, volunteer onboarding target goal. Community Outreach Manager Pantoja responded that there is no target goal, OC Animal Care does not have a need to recruit more volunteers.
- Committee Member Thomas asked if there is an age limit. Community Outreach Manager Pantoja responded that they must be at least 18 years of age.
- Committee Member Feinberg asked on average how many volunteers OC Animal Care has every year. Community Outreach Manager Pantoja replied over 200. Committee Member Feinberg asked if dog walks are tracked on a database. Assistant Director Schmidt replied that Chief of Animal Services Operations, Frank Foran, oversees, monitors, and deploys volunteers and staff to different buildings. Not every walk is not inputted into Chameleon software. Kennel attendants and volunteers work together to attend to kennels.

Public Comments for Volunteer Program Report

None.

It was moved by Committee Member Dr. Malo, seconded by Committee Member Feinberg.

6. Adoption Partner Program Report – Sandy Pantoja, Community Outreach Manager

This report summarized the first quarter activities of OC Animal Care's Adoption Partner Program including animal rehabilitation placement, quarterly adoption partner program roundtables, and enhancements to the Rescue Track website via TLC tab.

Public Comments for Adoption Program Report

Speaker #1 commented that the rescue group meetings consisted largely of volunteers and rescue partners should have non-escorted access to kennels for walkthroughs. This would be to conduct assessments of the dogs around new people and prevent staff from losing time. Was told that the only way to walk through kennels is to become a volunteer which takes a lot of time. Changes in veterinary exam policies make it difficult to work with OC Animal Care. Liked the TLC update. Stated there is no risk to OC Animal Care for kennel walkthroughs as a partner due to signed agreements and certificates of insurance.

Speaker #2 commented that they agree with the previous speaker. Wants to know how more volunteers convert to better outcomes for animals. Reported numbers are not showing where the operation is improving. Concerned that social media comments are turned off. Felt like the people are not being utilized. Questioned about the procedures to submit data to the committee.

It was moved by Committee Member Dr. Malo, seconded by Committee Member Kane.

7. Director's Report

This report included a litigation update, 2022 in review, overview of animal population crisis, and discussion of OC Animal Care's adoption model and positive placement.

First quarter statistics conclude 93% dog save rate and 80.17% cat save rate.

Partner HEART resumed mobile low-cost spay and neuter clinics at OC Animal Care.

Public Comments for Director's Report

Speaker #1 commented that their analyses are based off public record requests. It is accurate so long as the shelter provided accurate data. Is concerned about the 7% kill rate. Does not believe OC Animal Care can continue to be a top-tier shelter will a climbing kill rate. Return rates for animals are the highest ever. Advocates policy change to make adoptions easier and for people to see dogs in their kennels. Behavioral needs must be met such as through play groups.

Speaker #2 commented the YouTube videos of animals and TLC category on Rescue Track is good. Is concerned that there are only 42 biographies out of 129 available dogs. There needs to be more. Wondered if bites are being tracked. Need consistency and specifications for partner alert emails, appears that smaller dogs are given more time than larger dogs. 2022 cat save rates appear skewed, not taking into consideration euthanized litters without rescue commitment. Wondered if return rates and animal surrenders are being tracked.

Speaker #3 cautioned the committee that the shelter's statistics are being reported quarterly, instead of monthly. Creates the appearance of a more stable rate to cover mass euthanasia. Requested an audit of 2022 data, quarters are not adding up. Data is not collected or reported accurately.

Board Comments

Committee Member Feinberg requested a follow-up on microchip scanning at intake. Director Bernard stated that impounded animals are scanned. Committee Member Feinberg asked if OCAC could scan a lost animal to confirm if they are lost or to possibly contact the owner. Director Bernard stated they would take scanning without impound into consideration. Many veterinary clinic and pet stores offer microchip scans. Committee Member Feinberg suggested to correct the website for discrepancies.

Committee Member Thomas commented that these meetings are helpful to discover discrepancies and to listen to feedback. Committee Member Feinberg wanted transparency and clarification to make sure the public is not confused on services offered.

Committee Member Feinberg asked for a follow-up on the spay and neuter program. Director Andi stated OC Animal Care's partner HEART resumed their mobile spay and neuter clinic.

Pet Food Pantry

In June, OC Animal Care celebrated the three-year anniversary of the Family Furst Drive-Thru Pet Food Pantry!

Launching in June 2020, this program provided much-needed assistance to pet owners in the community through a pet food giveaway. The contactless drivethru events, staffed by compassionate team members and dedicated volunteers, aimed to distribute pet food and supplies to families facing financial difficulties.

Since its inception, over 190 tons of food has been distributed, feeding over 24,000 pets.

The success of the Family Fur-st Pet Food Pantry not only lies in providing essential resources but also in fostering a sense of community. This past quarter, over 76 volunteers, from UCI, PIMCO, MMA and Boeing, contributed more than 310 hours to staging, directing traffic, giving great customer service to people in our community, taking stats, offering education opportunities, and handing out over 39,820 pounds of food to over 2,123 animals in need.







Foster Program

Animals are placed into foster homes for various reasons. They may be too young or too sick for adoption, they could be receiving treatment, or they need additional socialization. OC Animal Care's foster caretakers offer sanctuary for these animals in their homes, and provide around the clock care, comfort, and socialization until the pet is ready for adoption. They are specially selected by our veterinary staff for their health and temperament and just need a little personal attention and time before they are ready to make their adoption debut! The foster caretakers are a vital piece of the OC Animal Care family. This quarter, there has been a total of 571 animals in foster care. Our foster caretakers are saving lives!

Kitten Shower on April 15th and June 24th

This quarter, the Foster Program hosted two Kitten Showers. The event highlighted how our Foster Program works, what it takes to be a foster, and how to care for your foster kittens. Attendees will not only learn about the foster program, but they'll also receive bottle feeding training and can ask questions of our foster team and a registered veterinary technician (RVT).

The first 25 families to sign up to be a foster at the event will also be receiving a foster starter kit thanks to the sponsorship of Supervisor Doug Chaffee. The foster starter kit includes a pet carrier and essential items needed for any foster to get started.







<u>Kitten Club</u>

The Foster Team has designed this series of course to give caregivers the essential information they need to help orphaned kittens thrive. It has been useful to both seasoned foster parents and those just getting started saving lives.

Here are our past Kitten Club Lessons:

04/01/23: Bottle Baby Training: what supplies you may need, how to set up space in your home, how to bottle feed, and how to provide bathroom assistance, grooming, and comfort.





05/06/23: Veterinary Kitten Care and Diseases: Feline Upper Respiratory Infection, Ringworm in Cats/Kittens, Feline Panleukopenia, Fading Kitten Syndrome, Diarrhea & Vomiting, and how to give/apply medications.

06/02/23: Caring for kittens from birth to eight weeks (Bottle Feeding, Stimulating, Weaning, Litter Box Training, Bathing, etc.).



Coffee with Fosters

The Foster Program hosted the quarterly Coffee with Fosters on May 20. This was an excellent opportunity for fosters to meet the Foster Team and discuss program ideas & plausible Foster Program enhancements.







<u>Dog Foster</u>

On June 24, OC Animal Care launched our Dog Foster Program! This initiative provides shelter pets a much-needed break from their routine by enjoying a "Staycation" in a foster parent's home. Our fosters complete an application and attend an in-person orientation to learn about the program. Once paired with a shelter pet based on preference and abilities, foster parents and their foster dog embark on their enriching journey together.

We had an outstanding turnout for our June orientations, with 30 fosters eagerly participating. Since the program's launch, seven dogs have already enjoyed their wonderful "Stay-cations," decompressing and unwinding in a loving environment.

Meet Walter, one of our success stories! He was the first to participate in our foster program and has already found his forever home, all thanks to his amazing foster parent. They provided him with a safe and loving space to decompress, learn new tricks, and relax.







Volunteer Program

This report summarizes this quarter's activities for OC Animal Care's Volunteer Program and includes contribution hours, program enhancements/ opportunities, and volunteer participation. Volunteers contributed to exercising, grooming, handling, training/ socializing, and enriching available animals, as well as cleaning, laundry, socializing kittens in the nursery, and volunteering at our monthly Pet Food Pantry. Volunteers are also responsible for showing dogs at our weekly Pooches on the Patio event, as well as numerous offsite Adoption and Educational events.

This quarter 213 volunteers have provided 6,174 hours at the shelter.

- Dog volunteer hours: 4,592
- Cat volunteer hours:1,718
- Event volunteer hours: 612

New Volunteers

This past quarter we are continuing onboarding new volunteers. We have been having monthly volunteer orientations and recruitments. This quarter we have brought on 49 volunteers, and they are in various stages of training and assimilation based on their areas of service.

Adoption Partners Program

Through cooperative actions, the Adoption Partner Program seeks placement for animals which need rehabilitation or additional support to be successful in their forever home. This report also reviews steps being taken to increase and improve adoptions and communication between OC Animal Care and Adoption Partners.

Adoptions Partner meeting

On April 5, we hosted a round table with our dedicated rescue partners. We reviewed our new TLC page that was added to our OC Rescue Track website. We also did a presentation on how to best interpret the medical histories we provide to our adopters. Afterwards as a group we had a great discussion about major trends in sheltering and rescue and had the attending groups work together to provide us valuable input on how we can all work together to help more pets in the community.

<u>Transports</u>

This quarter we worked with a few of our out of state partners to transfer 37 dogs out of the shelter. One group is a senior sanctuary. Our wonderful volunteers helped deliver 7 little senior dogs to a transporter who takes them to their rescue destination. The other 30 were transported across several states by our own dedicated animal control officers to a shelter we work with that has been very successful in placing some of our more challenging small dogs. They have also been helping us relocate some of our cruelty case dogs so their previous owners do not have access to try to get them back. These are great opportunities for those dogs to have a chance at a new life in a safe home.








New OC Rescue Track Feature

This quarter, we were able to implement the addition of a new web page highlighting our pets who are available in our Foster Program on our OC Rescue Track website. The OC Rescue Track website is designed to give our rescue partners current information on the pets in our care and help them determine if the pets would be good additions to their organizations. Now, our partners can view pets that are looking for foster homes and see if they can match pets to their foster homes. Many organizations like to be able to see all the available pets when making selections. This web page will also be available for our shelter foster parents to help them pick animals they would like to foster.

This new web page will give the rescue partners an opportunity to adopt these pets quickly and reduce the number of days they spend in the shelter. The pets on this page are able to be separated by species to make it easier for rescues groups to identify the pets they are interested in. Pets that are with our temporary guardian fosters are highlighted since they are not on site.

Each Pet has a photo and brief description, including the name, breed and weight of the pet.



Each pet has two request types. One is for fostering for OC Animal Care and the other is for rescues to request the pet. Foster inquiries go directly to the foster department so they can be helped immediately. Rescue inquiries go directly to the rescue department for assistance to get the pet placed with rescue. These requests are monitored 7 days a week during business hours.<u>Partner Adoptions</u>

This quarter, 769 animals (194 dogs, 459 cats, 116 exotic/other animals) were placed with non-profit rescue groups, local veterinarians, or with partnered





municipal and/or humane organizations. We sent out over 75 postings to our partners and networkers asking for assistance with our special needs pets. Our amazing partners continue to be a big part of our success in placing hard to adopt pets.



Success Story

Major was a young German Shepherd that was trying to survive on the streets for almost a month. Many people were trying to befriend him and catch him, but he was too evasive for them. Our officers set live trap and baited it with food to draw his attention and he was eventually captured and brought to OCAC. Major was not very trusting of people after his ordeal and was having a hard time adjusting to the shelter environment. We were able to work with Coastal German Shepherd rescue to find him placement in one of their foster homes, which ended up being one of the many people that had been trying to befriend him when he was a stray. After a few days in a quiet environment where he could decompress, he started to fit right into the family. We are all so happy that Major's story had such a happy ending.
